



## 2019-2020 THIRST PROJECT GALA TRIP

**DESCRIPTION:** Thirst Project is a non-profit with a simple mission: Build a socially-conscious generation of young people who will END the global water crisis. We do this by educating students and activating them to rock the clean water cause & build real water projects all over the world. We want to celebrate our students who decide to take action with Thirst Project. This year, we are giving away a free trip to our Gala (Flight, Hotel, and ticket to Gala included) to one lucky student who takes action with Thirst Project.

**HOW TO ENTER:** There are two ways to enter this trip. First, create a fundraising page under our online school tour campaign ([my.thirstproject.org/champion](http://my.thirstproject.org/champion)), and raise at least \$25 on your page. For every \$25 raised on your fundraising page, you get one entry into the sweepstakes. For example, \$25 raised on an individual fundraising page is one entry, \$50 is two entries, \$100 is four entries. The second way to enter is to donate \$25 to the overall school tour campaign ([my.thirstproject.org/champion](http://my.thirstproject.org/champion)). The donation must be made to the overall campaign to be eligible, not an individual fundraising page. You must be a STUDENT and you must have either CREATED your own page and raised at least \$25 on that page, or donated \$25 to the campaign before the "Drawing Date" of April 30th, 2020 to be eligible. For every \$25 raised on a fundraising page, the fundraising page creator will receive one entry into the sweepstakes. For every \$25 donated, the donor will receive one entry into the sweepstakes. Fundraising pages or donations outside of the general school tour fundraising campaign ([my.thirstproject.org/champion](http://my.thirstproject.org/champion)) are not eligible. For more information, please read the Official Rules below. All entries must be received within the Promotion Period.

Upon contacting a winner and determining that he/she has met all eligibility requirements of this Promotion, including, without



limitation, the execution of required waivers, publicity and liability releases and disclaimers, such individual will be declared the winner of this Promotion (the "Winner").

**PRIZE:** Subject to the Sponsor's right to revoke the Trip, there will be one (1) Winner, and such Winner will be entitled to a Trip in the amount no greater than \$1,500. The Sponsor will cover trip costs (including flight, hotel, and your ticket to Gala up to \$1,500, not including food) which will be paid by the Sponsor directly to the airline/hotel companies designated by the Winner.
